Associate membership is not open to family members, employees, business partners, and other individuals directly involved in the operation of MFMGA vendor member farms or businesses. The annual Associate membership fee is \$50. **Applications may be submitted at any time throughout the year.**

Newly accepted Associate members approved by the Board of Directors from January through April are entitled to voting privileges at the start of the forthcoming market year (e.g., May 2016-April 2017). New associate members accepted at other times of the year are entitled to voting privileges for the duration of the current market year.

Applicants must complete each application section in full, sign the application, and submit fees payable to Morgantown Farmers Market Growers Association (MFMGA). Incomplete applications will not be considered.
